## PANDEMIC; WILL RENEW FOCUS ON HEALTH ACCESS ISSUES AND SOCIAL NEEDS REVEALED IN NEW REPORT

Hawaii's nonprofit hospitals announce five priority intervention areas to address in their unique populations, in collaboration with key community partners

**HONOLULU – HAH.org –** New research released today by the Healthcare Association of Hawaii (HAH) shows that the COVID-19 pandemic has intensified the unique and significant health needs of Hawaii residents, especially those who were already struggling to make ends meet before the pandemic began.

The Community Health Needs Assessment (CHNA) report is produced by private hospitals every three years as required by the IRS, and it identifies the significant health needs of the community, based on input from the community. Hawaii is unique among states in that all private hospitals collaborate to produce a core report that is then customized by each participating hospital. Each hospital also identifies action steps to address targeted health needs, some of which are the subject of existing efforts with community partners.

The 2021 CHNA report identifies 11 significant health needs. Five rose to the top as highest priorities:

- 1. Financial Security
- 2. Food Security
- 3. Mental & Behavioral Health
- 4. Housing
- Trust & Equitable Access

These "social determinants of health" are conditions that affect a wide range of health, functioning, and quality-of-life outcomes. Social determinants of health are risks in the unique communities in which people are born, live, learn, work, play, worship, and age<sup>1</sup>.

The CHNA report also includes best practices for addressing these issues; strategies for actionable steps to be considered by hospitals; and policy opportunities to better address these areas.

The report is the culmination of input from more than 200 people, 82 key informant interviews, 18 community meetings, three expert panel webinars, four small focus groups, and an extensive literature review of both local and national data throughout 2021.

"This work is about hospitals joining forces with their community partners to expand beyond the walls of their institutions and into their communities as they provide care in multiple settings and improve wellness," said HAH President and CEO Hilton R. Raethel.

"In collaboration with cross-sector partners, hospitals are moving upstream to get ahead of health challenges faced by the unique populations they serve. Improving the health of their community and reducing the need for hospitalization, particularly for chronic disease, is a primary goal. They're looking for positive health outcomes long before residents need hospital care. This work represents almost a year of research, collaboration, and the sharing of best practices across many sectors," he said.

HAH is the nonprofit trade association for Hawaii's hospitals and other healthcare providers. It represents more than 170 organizations, including acute care hospitals, skilled nursing facilities, assisted living facilities, Type II ARCHs, home health agencies and hospices.

Hospitals will be customizing and releasing their respective action steps over the next six to ten months, and will make them available to the public on their websites.
