## FAQ cont.

#### Who can contribute?

Anyone employed by an HAH member and who is also a United States citizen may contribute to the HAH PAC. In accordance with federal law, all contributions to the PAC shall be voluntary and no contribution may be solicited or secured by force, intimidation, financial reprisal, as a condition of employment or membership, or by any other means prohibited by laws and regulations. Contributions to the HAH PAC are not reimbursable by an employer, spouse, significant other, or other party.

#### How much can I contribute to the PAC?

Individuals can contribute up to \$1,000 to the PAC in an election period. This means that an individual can contribute a maximum of \$1,000 during the primary election and another \$1,000 during the general election for a total contribution of \$2,000 over the entire election cycle.

## FAQ

## How is the HAH PAC different from the federal PACS, like the American Hospital Association (AHA) PAC?

The PACs of HAH's national affiliates – the American Hospital Association and the American Health Care Association – support candidates in federal races. The HAH PAC can contribute only to state candidates.

Checks written to the HAH PAC will be used only for HAH PAC contributions. No money goes to candidates in federal races. You can contribute to federal races via national PACs separately.
